Certified Internal Auditor® (CIA®) Designation

The CIA is the only globally accepted designation for internal auditors. It is the standard by which internal auditing professionals demonstrate their competency and professionalism in the internal auditing field. Candidates leave the program enriched with educational experience, information, and business tools that can be applied immediately in any organization or business environment. There are more than 185,000 CIAs worldwide.

The CIA exam is a three-part exam consisting of 125 multiple choice questions in 2.5 hours for Part 1, and 100 multiple choice questions in 2 hours for Parts 2 and 3. The exam is computer-based and available on-demand through Pearson VUE locations.
